Projects Implemented:

Empowering Community:

JVP organised awareness camps by the team “**Jharkhand Adivasi Nukkad Natak Dal**” in three clusters-Jaraki, Dumerchir and Pachuwara clusters of Amrapara block and covered 12 villages.



Local artists used local cultures and traditions in the play which resulted in outstanding taking of communities. Around 679 people including 117 girls, 140 boys, 195 males and 227 females witnessed the awareness campaign. The focuses were on:

- MGNREGA
- Pradhan Mantri Matri Bandana Yojana (PMBY)
- Pradhan Mantri Awas Yojana (PMAY)
- PDS
- Social Security Scheme (Pension)
- Gram Sabha

Outcome:

- *Communities became aware about different public schemes, its provisions and entitlements.*
- *CBO/TRF members' created space in panchayat office.*
- *CBOs generated work plan by conducting Gram Sabhas in the villages.*
- *CBO members named Markus kisku, from Udalbani Village, Bazel Tudu from Badabasko, Mitali Soren from Badasalghati and Maha Hembram form Bhatikandar played important roles in PMAY and ensured quality.*
- *Use of Public Information Centre (PIC) increased. They took support of the centre to reach out to various government departments.*

Public Information Centre:

A Public Information Centre has been already running by Jharkhand Vikash Parishad at Dumerchir Panchyat Bhawan. The objectives of establishment of the PIC are:

- Disseminate information related to various public schemes.
- Provide counseling and support the rural tribal people to avail the services.

The PIC remains opened twice a week i.e. on Monday and Thursday and people visit the PIC to seek information about public schemes and give applications to avail the services. Rest five days, the PIC counsellor, visits the community people and give information to them about the schemes and encourage them to apply. PIC identifies the socially concerned active CBO's from different villages as a volunteer for better communication with the people. The applications reach to PIC through volunteers, they assist the works of PIC and they are on a rotational basis.

PIC has huge role in motivating people to meet the Govt. officials and visiting banks, PIC maintains a follow up procedure and monitor the progress. PIC builds the bridge between the block office/Panchayat office and work closely with the block administration.

Institutional Building:



The Self Help Group programme mainly focused on empowerment of rural women and making them financially, socially and socially capable. The JVP programme's indicators women empowerments are:

- Able to contribute towards the family income
- Skill up gradation
- Understand the banking operations
- Improved standard of living
- Better leadership and communication skills
- Awareness in health education
- Take decisions in community, village and in households
- Filling the gap of drop out members.

In 30 villages of Dumarchir, Pachuware and Jaraki Panchayat of Amrapara block, extensive trainings and exposures provided to CBOs to strengthen their capacities and increased understanding of deprivation. With the support of **Johar Project (JSLPS)** JVP organised one day training programme at Dumerchir Panchayat, Amarapara. The training contents:

- Leadership and its processes.
- Meeting process-continuity and attendance.
- Decisions making- process and engagement.
- Recordkeeping- punctuality, transparency and verification.
- Problems Solution of SHG members and organization rules.
- Networking economically and socially with local organization.
- Filling the gap of drop-out members

Outcome:

- *The total saving of 52 SHGs reached to Rs.14, 23,876/-(Fourteen Lacs Twenty Three Thousand Eight Hundred and Seventy Six Rupees Only).*
- *48 SHGs Groups get linked with JSLPS (Jharkhand State livelihood Promotion Society). 28 SHGs received first and second Installment of Rs-10, 32,000/- .*

- 22 SHG's members of Tatitolla, Chottapaharpur, Budhiduba, Bhatikandar, Jetke tolla villages took loan of 3,000/- each group and started grocery shop, gantry, piggery, chicken farm, and cultivation.
- 02 SHG's and 1 CBO member of Nipania, Taldiha, and Malipara village established 3 flour and rice mills by taking loans from SHGs.
- 23 SHG's started kitchen garden.
- 48 SHGs applied independently for different schemes and lobbied with the government officials.
- 51 SHGs independently maintained records.
- 51 SHGs started operating inter loaning activities.
- 51 SHGs maintained the meeting registers.
- 105 SHG/CBOs took the responsibilities of toilet construction.
- 69 CBOs started addressing social issues like child marriage, education, stop migration and quacks.
- 54 women with the support of core committee raised the issue of pension, LLY, PDS and PMAY in the Gram Sabha.
- 132 CBOs raised the issues related to PMAY (Pradhan Mantri Awas Yojana) at block level.

- 69 CBO's members monitored the Public schemes.
- 22 Girls linked under Laxmi Ladali Yojana
- 14 children got admission in KGBV (Kasturba Gandhi Balika Aawaseeya Vidyalaya).

The village Nipania towards greenery:

The village is situated in Rajmahal hills range and on the tributary of Bansloi River. Although the area is rainfed, 80% rainwater is wasted by runoff and soil moisture gets dried up immediately after the monsoon. The inhabitants of the village mostly belong to scheduled tribes; depend on agriculture and forest produces. The village facing:

- Acute shortage of water for human consumption and agriculture
- Rapid soil erosion resulting low fertility of the agricultural land
- Low rainfall over the years caused severe deforestation
- Rapid reduction of soil fertility and lack of water facility causing livelihood opportunities.

Jharkhand Vikas Parishad with Integrated River Basin Management Society (IRBMS), a professional organization working in the areas of natural resource management has initiated

an ecologically viable development work in land, water and energy sectors leading to sustainable socio-economic improvement in Nipania. It is an attempt to improve the living condition of people by creating:

- More water sources to meet agricultural and domestic needs
- Improve soil and moisture content for better land use



Childline:



JVP operating child care and protection services in 125 villages, 10 panchayats, of Amrapara block. Total 5 staff is engaged in Childline.85 cases registered,70 cases referred for medical care and 20 cases produced before CWC for counseling, care

and protection of the child.1098 toll free telehelpline operates 24x7 hours and communities

actively taking the services of this emergency phone number. Amrapara police department, health department and schools are the major stakeholders.



Rights for Optimum Livelihood options through Empowerment and Self Reliance (ROLES): The project is focussed on the awareness generation of women and adolescents towards constitutional literacy and process of accessing entitlements.



There are 16 self Help groups and 12 adolescent groups in the operational area. Major points of the project are:

- Income generation of small and marginal farmers by on farm, off farm, forest initiatives and other linkages
- Women demand their rights, entitlements and perform the social and constitutional duties
- Improved maternal and child health care by strengthening of health system for Routine Immunization
- Enhanced ability of adolescents, both girls and boys, to make decisions about matters, be it psychological, familial, social, or economical, that affects their lives

The beneficial initiatives are formation of farmer's club, land, water management, weed management, seed treatment, crop rotation, mix-vegetable cultivation, pest management, use of organic manure and accessing government schemes related to agriculture.

Several training programmes organised like; PESA and Gram Sabha Management. 60 women and adolescents participated in the programme and it took place at Dumarchir Panchayat Bhavan 11.7.18.

Another one day training program was organized for the women at Piprajore Upgraded Middle School on 25.10.18. Ms. Fulmoni Soren facilitated the training. The topics covered; gender equality, right to vote, rights in MGNREGA and right to live with dignity.



40 SHG members attended one day training programme on SHG management at Middle School Bara Salghati on 13.7.18. More 80 SHG members attended training program organized at Fatehpur Kisaan Bhavan on 17.08.18 and on 07.09.18 at Santhali Panchayat Bhavan. Topics covered - ante and post natal check up, village health nutrition day, routine immunization and importance of nutritious food intake.

The target area is malaria prone area. Therefore SHG women made aware on vector borne diseases especially Malaria. One day training program was arranged at Santhali Bhavan on 7.9.18. 50 members attended the training program. Kalpna Kumari was the resource person.

Training of adolescents on Child Rights and Sexual and Reproductive Health including pre-marital relationship, incidence of teenage pregnancies and HIV/AIDS - 40 adolescents

participated in the training held at Middle School Salpatra on 14.12.18. Kalpna Kumari facilitated the training. One day training was organized for adolescents. 30 girls made aware on right to education, Rajiv Gandhi Scheme for empowerment of adolescent girls, prohibition of Child Marriage Act 2006. Ajay Murmu facilitated the training programme.

Reduce the adverse impact of forest degradation in 10 villages of Amrapara:

The desire of human beings to raise the standards of living and make the life comfortable has resulted in increased demand for food, air, water and energy. As the resources are limited so serious implications are there on the survival of both human and animal species.

The project says that natural resources are limited and the consumption must be rationed and planned so as to ensure sustainable development. The goal is conserving, protecting and regenerating forest coverage, maintaining and preserving water bodies in 10 villages of Amrapara Block (Pakur). It also aims to create awareness on environment education among various sections of society especially with youths, teachers and school students. Rallies on environment protection have been organized involving school children. Forest officials and guards have been engaged too for dialogues and discussion on forest conservation. World Water Day is celebrated on 22nd March to increase the awareness among the people about the importance need and conservation of water. The theme for World Water Day Celebration is "Leaving no one behind". Talks organized and water related issues got highlighted.



Advocacy Initiatives:

Four Meetings of District Level Tribal Right Forums organized in the months of 29th March'18, 22nd August'18, 20th September'18 and 21st November'18 at Santhali Panchayat Bhavan and Dumarchir Panchayat Bhavan, Amrapara, Pakur. 32 males 28 females participated in the meeting. The discussion points:

- Strategy to identify the issues and solutions.
- Sustainability of TRF.
- Fund raising components.
- Linkage with social security schemes in 30 villages.
- Monitoring different schemes at village level.
- Raise the issues with higher government officials/STRF.
- Motivate the community to join CBO and campaign on the right based issues.
- Identify common issues for STRF meeting.
- Action Plan for the next quarter

Outcome:

- *The District Level Tribal Right Forum raised the issues at community level.*
- *TRF are took initiatives regarding fund raising from the community by doing activities at community level..*
- *Building Linkage and sharing their best practices with government functionaries. As in Dumarchir PMAY amount taken out by the middle man without informing the beneficiary. This incidence was highlighted in the media and he was caught.*
- *DTRF raised the issue of fair selection of Sévika, Sahiyya and proper implementation of MNREGAs.*
- *TRF members also taking part in monitoring of Schools, ICDS, and PDS system.*

Two State Level Meetings of Tribal Right Forums organized one held on 7-8th June'18 at



Domdih Sidhu Kanhu Ashram, Sunderpahari, Godda and second one was held on 3-4th September'18 at BITM, Kanke, Ranchi. 16 males and 24 females participated in the meeting. The discussion covered:

- Experience sharing of district wise.
- Sustainable Development Goal.
- PIC centre and volunteering their responsibilities at village level.
- Participation in Gram Sabha.
- Discussion on schemes like PDS, SOCIAL SECURITY, MGNREGA etc.
- Setting of action plan for next six months

Outcome:

- *STRF members identified common issue of operational area (Pakur) for state level advocacy.*
- *Dialogues with District and State level departmental officers helped to release the delayed payment (MGNREGA) and ensured more transparency*
- *Sharing with media the issues of target area like Delayed Payments, New Job Card, MIS of MNREGA, PMAY, Pension Scheme, PDS and Drinking Water Facilities.*
- *STRF has decided to follow up of issues for proper compensation for any loss due to conflict.*

Two Inter State meetings of Tribal Right Forums organized in the months of 18-19th June'18 at Ishoponhi Ashram, Puri and 28-29th November'18 at Gandhi Peace Foundation, Delhi. 10 males and 6 females participated in the meeting and the discussion points:

- *Sharing of information, experience and best practices by ISTRF.*
- *Fund raising for the forum.*
- *Strategy for continuation of state tribal right forum meeting after project ends*
- *Sustainable Development Goal.*
- *Identifying and raising tribal rights at ISTRF level.*
- *Lobbying with tribal commission and others government functionaries at state and national level.*
- *Setting of action plan for next six month.*

Outcome:

- *Two States members prepared petitions on PDS and MGNREGA (delay payment) and submitted to the Tribal commission New Delhi.*
- *Fund raising plan got prepared*
- *Network plan made*
- *Action Plan made*

Capacity Building programme on advocacy for TRF members:

Two days training programme was organised on social schemes at Domdih, Sidhu Kanhu Ashram, and Sunderpahari on 09-10th June'18. Mr. Balram, Mr James and Mr. Ashirfi Anand conducted the training.

Outcome:

- *TRF Member made aware about social security schemes/ provisions.*
- *192 women got gas connection through Pradhan Mantri Ujjwala Yojana.*
- *363 people worked under MGNREGA –Dobha and Pond Construction and land labeling.*
- *375 people demanded Job under MGNREGA.*

Training of CBO/TRF members on advocacy:

A two days training programme on advocacy for the members of CBO/SHGs was conducted at Dumerchir Panchayat Bhawan, Amarapara, Pakur on 29-30 September'2018. This programme involved the trainer Mr. John Soren, Mr. Lalji Tudu (Ward Member-Gogajor village), Mr. Bajal Tudu (Gram Pradhan) and Mr. Manoranjan Singh. The topics covered:

- Definition of advocacy
- Tools and methods of advocacy
- Lobbying and influencing
- Roles and responsibilities of CBOs/TRF
- Data collection/Facts and findings
- Leadership/responsibility
- Right to Information

Outcome:

- 02 RTI's filed by the CBO members of Bhatikandar and Bardaha village on PMAY and Road Construction.
- Connected with the State Women Commission, State Food commission, Child protection Commission and National Tribal Commission.
- Continuous advocacy efforts by the CBO/TRF members resulted in 3 dealers' suspension for their negligence.

Workshop on Forest Rights Act:



A state level workshop on forest right act was organised on 10th and 11th September; 2018 in Ranchi. 10 organizations participated in the workshop. The issues related with Jal, Jungle and Jameen (Water, Forest and Land) was discussed at length and all organizations made their plan on forest right activities. Jal, Jungle and Jameen are the mainstay of livelihood for rural population so it is expected that healthy and dynamic growth of three is important foundation for rural development.

Key achievements:

- 992 people visited PIC between 1st January' 2018 to 31st March 2019.
- 734 people submitted applications of different public schemes in PIC. 706 issues got addressed.
- 233 CBOs members got benefited from Pradhan Mantri Awaas Yojana (PMAY).
- 87 Women got benefited from Pradhan Mantri Matribandana Yojana (PMBY)
- 64 CBOs linked with Social Security Scheme.
- 06 people received PDS Cards.
- 09 Pond, 12 Dhobha and 32 goat=shed, 26 Nadep pits got constructed under MGNREGA Scheme.
- 22 Girls linked with Laxmi Ladali Yojana (LLY).
- 16 Hand pumps got maintained by PHED Department.
- 378 people demanded Jobs under MGNREGA scheme.
- 26 Volunteers selected from 16 different villages and they assisted PIC.
- 12 women CBO members received sewing machine from Labor Department.
- 74th Gram Sabha was organized at village level. With active participation CBOs raised various issues in Gram Sabha.
- 48 SHGs linked with JSLPS (Jharkhand State livelihood Promotion Society).
- 20 groups linked with JTDS (Jharkhand Tribal Development Society). Each group received Rs. Ten Thousand and total amount was Rs-2,40,000/-
- 12 Core Committee members got selected as teachers.

आदि ने बैठक में अपना विचार देते हुए कहा कि हमें समय के साथ अपने अधिकारों के प्रति जागरूक होना आवश्यक है। विभिन्न सरकारी योजनाओं से महिलाओं को किसी न किसी रूप में जरूर जुड़ना चाहिए। योजनाओं की गुणवत्ता की निगरानी भी की जानी चाहिए। इसके अलावे जड़ानी, पंचुआड़ा सहित दुरस्थानों से एकत्रित सदस्यों से मंच को चलाने के लिए 10 रुपये का सालाना सदस्यता शुल्क बैंक में जमा करने, पिछले तीन महीनों के दौरान पिटार भए करारी, बल होखा-जोखा सहित अगले तीन महीनों का कार्य योजना भी बैठक में तैयार हुआ। संगठन के प्रखंड समन्वयक मनोरंजन सिंह मौजूद थे।
