Genesis:

The Chief Functionary of the organization Ms. Subasini Soren is very actively involved in

the sector of social service after her graduation from Pakur district of Jharkhand with number of NGOs in Bihar, now in Jharkhand. While working with NGOs, she felt that she should initiate her own initiative in the sector of Rural Development with her ideologies and attitudes and formed the organization named 'Jharkhand Vikas Parishad' with the like minded people of Mandu block of Hazaribag. The organization has been registered in the month of June 2000. Since its inception, the organization has been working for the rural poor with special reference to women and children.



In the due course of action, the organization is intervening for the development of women and child through formation and promotion of women's groups, non-formal education, health & hygiene camps, environment camps, integration & promotion of traditional festivals, village meetings, capacity building training, organizing advocacy workshop on women's issues and promotion of livelihood activities to ensure Food Security.

JVP is striving its hard through its various integrated actions to attain an established, egalitarian, non-exploitative and socially just society with economic self-reliance.

Major Activities during the year 2010-2011

A. Our organization has been implemented several project supported by Government Departments, National level Donor agencies and International Donor agencies. The big project we have i.e. PAHAL Network Project supported by FYF, UK through technical support by Saskham India under the umbrella of Badlao Foundation, Mihijam, Jamtara. The specific objectives of the project are socio-0economic and health promotion of the Adibasis with especial reference to the women in 50 villages of Pakur district. Several development activities have been taken place under this project.

1. Health camps Through Mobile Van under NRHM:

Objective:

- To aware the people on preventive health issues
- To organize health camps, treat the patients, provide medicines instantly
- To make regular linkage with the PHC to leverage & access health facilities;
- To make project area people aware on NRHM facilities;
- To improve the health status of the target people with special reference to women & Children, the ways & means to improve it;
- To promote routine immunization, polio and TT-2 among the children & pregnant women;



General Health checks up of 1238 village people done by the Doctor and provided medicine free of cost by the Health Dept. as per the prescription. X-ray has been done for 60 people for T.B. testing, VDRL test for 17 people, TC. DC blood test done for 29 people, blood test done for 11 people for blood group identification, Blood test for malaria done for 71 people out of which 25 people are confirm malaria cases detected out of

which this 24 are brain malaria cases. Medicine has been provided to malaria confirmed cases. Brain malaria cases given saline immediately. 1 diarrhea cases was treated. Widl test to 7 person, Hemoglobin test to 31 patients and HIV test to 14 people has been done. No positive HIV cases found. Counseling on HIV/AIDS has been given to youths and migrant people. ESR test done for 14 cases, Alde hide test for 1 & Pregnancy for 4, Asotitate 3 test, urine routine test 15 done during the period, Triglyceride test for 1; HBsAg test for 5 persons, RBS test for 3 people, 4 ECG has been done for 4 persons.

As far as outputs is concerned, 1238 patients out of which 504 males & 734 female registered for treatment from minor ailments like fever, cough, headache, acid stomach, pains etc. 13 brain malaria cases given saline urgently after confirm detection by the mobile dispensary & sent to PHC. Necessary free medicines provided to the patients. 15 confirmed T.B. cases sent to PHC & covered under DoT program. Women members gained primary knowledge regarding HIV/AIDs. Target area people understand the causes of various diseases. Women members become knowledgeable on hygiene & nutrition. 209 women members participated in health check ups. Counseling given to the patients on individual issues by the counselor. Women members has been linked with Mobile dispensary for regular treatment

As far as outcome is concerned, increase knowledge regarding the conditions of better health. Increase number of people visiting PHC for treatment for minor illness & blood testing. 12 brain malaria cases become cured due to proper treatment. 10 T.B. cases are continuing their treatment. Knowledge increased among the people regarding Malaria & T.B. treatment. Increase knowledge on use of safe water from tube-wells. Knowledge enhance on

HIV/AIDS. Increased number of TT2 during pregnancy among the SHG members. Percentage increased in immunization coverage.

2. Health Awareness Camp:

Objective:

- To aware the women folk & people in general on total health issues
- To make the project area people aware on NRHM facilities
- To improve the health status of the target area people with special reference to women & children
- To promote routine immunization, polio and TT-2 among the children & pregnant women;
- To make regular linkage with the PHC to leverage & access health facilities;

The camp has been organized with the participating 89 mothers on various important health issues i.e. new born care, hygiene practices, importance of nutrition, TT-2, child care and so on. During course of our day to day activities we understand that, unless total health awareness will be increased among the SHG mothers, whatever income they will earn spent for treatment. So, health awareness camps have been given priority. 89 SHG members were participated actively. Local ANM & MPW act as a resource persons.

The outputs are, the SHG members actively participated. The members started acting as peer educators. Behavioral practices started changing. The outcomes are increased knowledge on health issues. Linkage with Health Sub-center for resources

3. Health Care training:

Objective:

- To organize issue based basic health care training
- To train the village people and women SHG members of basic health care practices
- To create awareness among the women folk on malaria
- To make aware of the SHG members on seasonal diseases
- To aware on birth preparedness, new born care, child immunization, nutrition & hygiene
- To aware on malaria issue as a priority

11 trainings have been organized with the village people along with women SHG members. Total 348 attended the training out of which 49 males & 299 SHG members were participated the training. M.P.W. and A.N.M. joined the training program as resource persons. The Project Team was participated the training as resource persons. The issues are relating to basic health care practices on seasonal diseases, birth preparedness, new born care, child immunization, nutrition, hygiene & malaria.

As far as outputs are concerned, increased knowledge on pre-post natal care, new born care, immunization & pulse polio. Awareness created on seasonal disease & malaria. Participants are now started using mosquito net.

As far as the outcomes are concerned, 45 women received TT-2. 13 women benefitted from JSY (Mothers survival/protection scheme). 363 children got immunization benefits. Participants enhanced knowledge regarding seasonal fever. Participants enhanced knowledge regarding Malaria & Safe Water use. Now the participants instantly are doing blood test after fever by the ANM/Sahiya. Hygiene awareness increased.

4. Sustainable agriculture training:

Objective:

- To train the village people & women members on sustainable agriculture
- To train the women on benefits of organic fertilizer (vermin compost) & pesticides (neam based & other local leafs)
- To keep informed the women members regarding utility & proper use of cattle waste & agro-waste
- To inculcate the possibilities of dry land farming due to drought

9 sustainable agriculture training has been organized in which 349 village people out of which 282 women SHG member & 67 males. The participants have been trained on sustainable agriculture i.e. seed processing & preserving, benefits of organic fertilizer, preparation & use of organic fertilizer, use of organic pesticides & dry land farming has been discussed. This time potato, wheat cultivation & vegetable cultivation has also been discussed with a special priority.

The outputs are, enhance knowledge regarding agriculture promotion, Gained knowledge on SRI technology. This enhanced knowledge on dry land farming. It increased knowledge on potato, wheat & vegetable cultivation. Enhanced knowledge on gram and mustard cultivation training

The outcomes are, 28 women members now producing vermi compost & use in their own filed. 120 farmers had been done cultivation only introducing vermin compost & cow dung. 3 women continuously produced earth warm & sale to others. 1.1 acre wheat was cultivation through new technology. 3 acres vegetables cultivation was one in different patches. 1 acre potato has been cultivation. People become interested on new technology introduction in agriculture. 3 SHG members cultivate 855 number of bringal vegetable. Growing interest of SHG members on 2nd crop & vegetable cultivation has been increased. 1 acre paddy cultivation was done through SRI technology by 4 groups. 4 acres beams cultivation done by 8 groups

5. Nutrition/crop diversification training:

Objective:

 To train the farmers on crop diversification based on land characteristics & water resources

One crop diversification training has been organized where 40 farmers were participated. The basic tune of the training was to motivate the participants not to continue only with traditional type of crop/farming. Other than traditional type of crop, various pulses and oil seeds take minimum water resource and give more benefits to the farmers. The participants were encouraged listing the variety of diversified crop pattern which they have never cultivated.



The outputs are build understanding regarding diversified crop cultivation. Women members motivated for alternative cultivation. The outcomes is the participants are now ready for cultivating diversified crop

6. Irrigation demonstration:

Objective:

To facilitate irrigation system for crop survival as well as crop diversification

- To provide water pump machine to the Kisan Samity
- To develop management system for smooth operation of the pumps
- To monitor the use of pumps by the KS themselves

7 water pump machines have been distributed to 7 Kisan Samity in which 148 farm families has been involved.

As far as outputs are concerned, storage rain water in tanks. Farmers got the machine & plan for cultivation after paddy harvesting. Surplus amount of running the machine has been deposited in the Kisan Samity (Treasurer) for future maintenance of the machines. The farmers beyond the Samity also got the benefit of pump machine.

So far the outcomes are concerned, total about 9 acres wheat, potato & vegetables has been cultivated through irrigation by the pumps. Integration among the farmers has been done for crop diversification & 2nd crop cultivation. This increased total irrigation & cultivation area. 5 prizes has been received by 2 SHGs & 2 Kisan Samity for best vegetable production (i.e. potato, coli flower, sim, wheat & jack fruit) in the Block Kishan Mela.

Leadership training:



Objective:

- To develop leadership among the women leaders
- To enhance knowledge on record keeping of women leaders involved with the task

One Leadership training has been completed. The Roles & responsibilities of the Chairman, Secretary & Treasurer was the prime theme of the leadership training. Importance of maintenance

of various records at the SHG level was the prime theme in Record keeping training. 142 women SHG members participated the training. The conditions of a model SHG, group solidarity etc. also has been discussed in the training program. It was a participatory training so the participants enjoyed and learn from training. Additionally linkage with Block officers has been done.

The outputs are enhanced knowledge on SHG functioning. This Gained knowledge on record keeping. Immediate linkage completed with block level officers. The outcomes are group leaders are now own contacting the banks for finance transactions. 8 groups are maintaining record by its own office bearers. Group members now directly talk with block officials. Local women leaders demands for financial inclusion.

8. Advocacy training:

Objective:

- To gained skill of advocacy
- To know the advocacy tools
- . To know how to organize Rally, Jahta, Public hearings, Workshop and Seminar
- To know Media workshop

The project team has been given 1 training on advocacy (ToT) at Badlao Foundation by Saksham India Team in which 5 project personnel & 2 village volunteers has been participated & trained. Back to the project the team has been organized one day advocacy

training with 20 beneficiaries at the project level. Different technique and tools for advocacy has been discussed

The outputs are the participants become knowledgeable regarding the importance of advocacy and creation of issue based public opinion in the area. The outcomes is the participants activity participated in the community campaign initiatives

Case study - 1

Smt. Fulmoni Hembram w/o Sheo Besra of village Littipara of Amrapara block attended the training on Agriculture extension (vegetable cultivation) organized by us along with other women SHG members. At the end of the training she become motivated too much

Back to home she convinced her Husband for Bringle cultivation. Finally the family decided for Bringle cultivation in 3 kattas of land. Total 410 plants have been planted. 100% survivals of plats are there. The plants has grows nicely, now started produce bringles. The entire plot has been introduced bio-fertilizer (vermin compost) & bio-pesticides (neem based)



They are hoping that, this year they will warn about Rs.6000/- (Rs. Six thousand only) from selling bringle. Seeing their effort other 2 families were also cultivated brignle in their land though off late.

This now becomes a nice demonstration cum learning plot to the local farmers. Each one now though off for vegetable cultivation in the days to come.

9. Community Campaign Initiatives:

Objective:

- To organize community campaign at the village level;
- To sensitize the community regarding project activities:
- To ensure community participation;

To inform the communities regarding Govt, Schemes;

11 community campaign initiatives has been completed in which 536 village people out of which 212 male & 324 female were participated the community mobilization meeting. The problems of the community, possible interventions and various Govt. Development schemes have been discussed in the meeting.

The outputs are enhanced knowledge of the participants regarding Govt. schemes. Understand the development issues. This creates of pressure to PRI & Block authorities. Increased visiting to Gram Panchayet & Block by the excluded communities

The outcomes are village people are now demanding for MGNREGS job. The People of the area asking for ration card, widows demanding for pension, Persons with Disabilities demanding cards & pension, demanding for BPL card, demanding for IYA & BPL card benefits by the card holders. They are demanding for creation of water resources & irrigation facilities also done by the people along with Tube wells for safe water to BDO.

10. Development of I.E.C. Materials:

Objective:

- To create awareness among the people
- To sensitize the rural people through IEC

Pictorial Pamphlets, flexible charts has been prepared on Nutrition & hygiene & printed in local 'Santhali' language, distributed to the village people and women SHG members. The village people see the photos/contents of the materials interestingly. They are being discussed with other community people regarding the IEC photos. So, the target area people understand the importance of nutrition, hygiene and safe water.

11. Wall Painting:

Wall painting has been done in 50 villages on water, sanitation ad hygiene issues which become attractive to the village people. This has been a learning spots to them.

12. NGO alliance Meeting:

3 NGO alliance meeting has been organized during the year in which 10 NGOs were participated in which 41 members participated to share our activities and learn from other's activities as part of exchange learning program & networking.

13. Environment Workshop:



To aware the village people on environment pollution one environment workshop have been organized in which 64 youth and women SHG members were participated. Various issues related to environment has been discussed & the way to combat it.

14. Provision for Livelihood Support Fund:

To support for livelihood activity i.e. Animal Rearing as per the desired by the families 112 women SHG members given

financial support for goat rearing, 3 members given small business, 7 members for has been for piggery. The beneficiaries purchased the chattels. This has reduced migration due to cattle rearing. Now the target bens properly rear the cattle.

15. Training / Meeting/ Workshop attended/Organized:

- Two days Forest Act Training (ToT) attended by 7 project staff at Dumka dated 15-16 July 2010.
- One Tribal Health training (ToT) has been organized at Badlao Foundation by Saksham India on 26-28 Sept. 2010. Five project staff has been participated.
- Organized the PAHAL Internal Review & review of PAHAL milestones by FYF UK & India office.



 Participated in the Observance of '50 years of FYF in India' at Lucknow on 15-16 November with 9 people cultural team.

- International Days' on 8th March 2011 in which 107 women participated Knowledge management training (ToT) has been organized at Badlao Foundation by Saksham India on 4-6 Oct. 2010 in which 5 staff members were participated.
- Internal monitoring on sustainable agriculture done by Mr. Avind Chouhan of Sakshasm India on 25 Nov. 2010 and visited filed activities with project team.
- Internal monitoring on Livelihood support done by Mr. Ashis Chakraborty of Sakshasm India on 18-19 Dec. 2010 and visited filed activities with project team.
- Tribal Health training (ToT) has been organized at Badlao Foundation by Saksham India on 2-4 Feb. 2010. Five project staff and two Sahiya has been participated.
- Orientation on Advocacy Campaign has been organized on 15-16 Feb 2011 at Badlao Foundation by Saksham India. All together 7 staff & PRI members participated.
- Knowledge management training (ToT) has been organized at ATMA, Dumka by FYF on 18 March 2011 in which 6 project members were participated.
- Promoted 3 numbers of NADEP Compost pits for promotion of organic compost as model demonstration to the farmers.
- 109 families application submitted for proper PDS distribution through effort.
- 5 Jagruta Jatha (Sensitization Rally) on Panchayeti Raj has been organised in the area through Nukkar Natak (Street Play). 342 people participated in the Jatha out of which 96 males & 246 female. Out 246 female there are 198 women SHG members.
- 5 Jagruta Sibir (Sensitization Camp) on Panchayet Raj has been organized at cluster level in which 106 women SHG members participated

Case study - 2

Smt. Lajwanti Marandi wife of Sri Chapra Hembram of village Dumurchi of Dumuchi Gram Panchayet Gram Panchayet of Amrapara block in one of the women SHG member of 'Kadambaha Swam Sahayata Samuha' among 14 women members. She is from a tribal family in a village in the hills. She has been actively participated in the SHG form the beginning.

Jharkhand as a state has completed its 3-Tire Panchayeti Raj election in the recent past after a long time. 50% reservation for women has been declared as per PRI rule by Govt. of Jharkhand. There is a unique feature in the PRI election i.e. PRI election will be without any recognized political banner or agenda. So number of women has been contested in Panchayet election to take part in the democratic process.

Smt. Lajwanti has been contested in the Dumuria Gram Panchayet for the post of Mukhia (Gram Panchayet Pradhan) and being elected in the post defeating other candidates as she was a known person in the area. She is now act as 'Panchayet Pradhan' and fell empowered and take care of the problems of the area with special reference to the women.

This has been possible as Smt. Lajwanti has been a member of women SHG promoted by Jharkhand Vikas Parishad and attended number of camps/trainings organized by our organization. She become smart, vocal and the leadership has been developed within herself to act as 'Mukhia'. We are really proud for her.

B. The other program our organization has implemented in Maheshpur block of Pakur district supported by Centre for World Solidarity, Jamshedpur. Various activities has also been initiated for the benefit of the rural people.

1. Village Level Mobilization & Sensitization Meeting:

The objectives of the meeting were to mobilization & sensitize the women folk regarding their rights. 5 such camps has been organized in villages i.e. Baskendari, Harishpur, Sharpur, Kolkhipara and Dumariya. All together 162 women participated the camp and knows about the rights of the women.





2. Gender sensitization Workshop at the village level:

The objective of the workshop was to build confidence among the women through gender sensitization. 5 workshops has been organized in 5 villages. The villages are Baskendari, Harishpur, Sharpur, Kolkhipara and Dumariya. 300 men and women were participated the workshop. The resources persons address the questions of the participants also.

3. Community awareness on women's Right

Community awareness program on 'Women's Rights' has been organized in 5 points of Baskendari, Harishpur, Sharpur, Kolkhipara and Dumariya villages. The objectives of the program were to bring awareness in the community about women's Right. 321 community people were participated the camp.

4. Advocacy on Govt, social security Schemes especially related to women:

The objective of the advocacy was to enable the rural women to become knowledgeable on the Govt. Schemes. The program has been organized in Sharpur village. In the advocacy campaign 60 women were participated.



5. Matri Milan Samaroha:

As part of observation International Women's day matri Milan Samaroha hs been organized in 5 villages i.e. Baskendari, Harishpur, Sharpur, Kolkhipara and Dumariya village. In each meet a large number of women were participated.

6. Workshop on Women Rights against domestic violence:



Today Indian constitution has given rights to the women to fight against all sorts of women atrocities and violence. The objective of the workshop was to educated the both the male and female of the area to aware on the acts and provisions so that the violence against women reduces. 54 both male and female were participated the workshop.

C. National Environment Awareness Campaign (NEAC):

National Environment Awareness Campaign has been the yearly program of environment

awareness among the people in general on various issues. The program has been supported by Ministry of environment and Forests, Govt. of India through GRAM VIKASH, Jamshedpur. Several program under the same has been organized at Mandu block of Ramgarh district.



1. Public Meeting:

The Public meeting has been organized in 2 villages i.e. Jorakaram and Bongahra in Ramgarh district on .Bio-Diversity Conservation' issues in which both 65 male and female were participated

2. Debate Competition to School Level:

On Bio-diversity Conservation issues Debate Competition has been organized with school children to increase their knowledge base. The debate has been organized in 2 schools i.e. Utkarmit Middile School Rangubera & Nonoyabera in which 84 Boys and Girls were participated and learn from the program.

3. Seed Bank Preparation:

1 seed bank has been developed in Dagadgiya village for sustainability of Agriculture and Environment practices by the local famers. The farmers of the village are very much enthusiastic about the initiative.



4. Plantation of Medicine Plants:

In Nonoyabera village 100 medicinal plants has been plated for sustainability of environment promotion as well as treatment on for minor illness. The farmers are very much interest for medicinal garden promotion.

5. Workshop of Bio-diversity:

One workshop has been organized at Dagadgiya on Bio-Diversity Conservation in which 43 rural people and farmers both male and female were participated. The participants also share their views on Bio-diversity.

D. Miscellaneous Activities:

1. Youth Sammelon:

Yuva Sammelan has been organized at Fatepur village at Amrapara block of Pakur district to make strong youth Groups and capacitate tem on youth related issues. 86 male & female were participated the event and enjoyed a lot. Earlier the youths never thought of such an attractive program for them in the area.



2. Agri / NRM Demonstration Training:

To promote sustainability agriculture for ensuring food security Agriculture/NRM demonstration training has been organized at Tatitola in Amrapara Block in Pakur District. The local seed provided to the farmers.



3. Womens Day:

Women's day has been organized to empower the women for their rights at Fatehpur village in Amrapara Block in Pakur District. 155 women were participated the women's day celebration.

4. Leadership Training:

To capacity building to SHGs women Leadership training has been organized at Fatehpur village in Amrapara Block in Pakur District. 74 women SHG members has been participated.

The project ended with leadership game which the women members enjoyed a lot.

Wall writing

Several wall writing has been done on Environment issues in various villages i.e. Dadagiya, Noniyabera, Bongahara,

Rangubera at Mandu Block in Ramgarah District in local language for educating the rural people on environment.

At the end, on behalf of our organization we would like to convey our thanks to our Donors, Govt.
