Johar Project: - Since 2014 JVP has been working to empower tribal communities to reduce their poverty and exclusion by improving access to and monitoring of public services.

Main objective of this project is to:-

- Increased access to quality basic services and government schemes.
- Increased awareness of their rights.
- Increased access to information
- Increased participation in community life.
- More transparent and accountable governance structures

In this course of action tribal women were organized into Self Help Groups, and in last one year 52 SHG's are formed with 654 members in its intervention areas. Members from 37 SHG's are trained on book keeping and records maintenance, 38 SHG's have opened their accounts in the banks and 644 members are involved in Income generation activities.

30 CBOS' were formed with 2700 members and apart from this one Public Information Centre has been established so that community people can get access to different types of public schemes.

Awareness creation has been done by printing around 500 IEC materials

One State Level Tribal Forum has been formed with 4 members (2 men and 2 women).

Advocacy:-

Members were made aware of the need to have their own identity cards. They also helped in the process of enrolment for BPL Cards, Smart Cards, Voter ID Cards, Ration Cards, etc.

Members were linked to the benefits of various schemes like JSY, MANREGA, etc

We all know that more than 93% of workforce is self employed and depends upon unorganized sector for livelihood. The major security needs of the unorganized workers are food security, nutritional security, health security, housing security, employment security, income security, life and accident security and old age security.

JVP has been advocating for social security schemes. To demonstrate the benefits of such schemes, it has been implementing such schemes on a contributory basis since last couple of years.

Success Story:-

Barish Murmu 35 years old resident of Gogajor village of Jaraki panchayat, district Pakur. Barish's family includes his wife named Suraj Kisku aged, daughter named Silwanti Murmu aged 10 and a son named Albinush Murmu aged 5 years old.

My whole family got involved in Johar Project implemented by JVP. Later I became member of *Community based organization (CBO)*. My wife Suruj Kisku is also became member of *Core Committee* member. My wife participated in different types of trainings related to SHG/CBO and other Public Schemes like Indira Awas Yojana and MGNREGA Scheme, Advocacy & campaigns on SHG/CBO.

After attending different training and meetings I gained detail knowledge about different govt.



schemes. And I decided to apply for Indira Awas Yojana. I applied through PIC run by Johar project and implemented by Jharkhand Vikas Parishad, supported by FYF. Then I applied for job card and now availing the benefits related to it. I and my wife both are MNREGA labour and getting wages from the scheme. Now my financial condition is improving and I am happy that my financial status is improving.

Before getting in touch with the staffs of Johar project my life was little different, with limited knowledge on Govt schemes. I did not had any access to Govt. scheme .I was not aware about the best education for my children. I had less knowledge about importance of good health. Agriculture was the only source of income for supporting my family. People (in *Santhali & Paharia*) are shy in nature and hesitant in communicating with others. The literacy rate is also low due to which people lack confidence as result they are unable to raise their voice.

After joining the project .I and my family got benefitted .My wife began to participate in meetings and trainings organized by the project and started sharing in family. We came to know how we can approach for various Govt. schemes and what the proper channel is. I am able to approach Govt. officials and PRI members. I became an active member of CBO and understood the benefits of IAY scheme and gained clear concept about scheme. So I went to PIC and received enough knowledge about IAY scheme. Then I applied for my own IAY and benefitted under the scheme. I gained knowledge for different Govt. Scheme by participating in various trainings programs organized. I actively participated in various training and my self confidence, self esteem and leadership qualities increased.

After joining the *JOHAR Project* I found my self esteem has increased and started availing benefits under different govt. schemes.

Earlier I was not interested to participate in the *CBO's related* meeting but now I am actively attending the meeting organized by the project. As this helps me to gain knowledge and knowledge is the power through which I can fight for my right. Now developed a sense of pride as started attending meetings of CBO's organized by *JOHAR projects* which helped me to increase in my self confidence.

CASE STUDY –

Knowledge Chnaged Life of Merila

Brief Case history:-

Merila Tudu a 37 years old lady belongs to a rural family with two

daughters and husband named Lourance Soren stays in Rodgo village which is near about 07 k.m from Littipara block and for their survival the family basically depends upon agriculture and forest products. At the beginning when Merila used to attend our program she was quite shy and hesitant to speak anything. During her initial visits to our activities she was a silent participant and her husband was prohibiting her to attend such programs. In spite of resistance from her husband Merila used to attend our programs regularly and was quite very silent and shy at the same time Merila was eager to learn new things.

Merila Tudu was uneducated, poor and very simple far away from modernization. During the program our project staff observed the sincerity and curiosity of Merila about knowing the new technology of agriculture. Field staff during their field visit met her and discussed with her about education, information on various schemes and economic empowerment and tried to know and motivated her to dream and achieve her dreams. They introduced the purpose and mission of KFB project. She started taking part in our meeting and training programme.

Merila attended various programs organized by KFB, like Sustainable Agri & NRM training programme and other demonstrations. She started seeing a ray of hope of development through these capacity development programmes.

Last year, she showed her interest of vegetable cultivation and our field staff and project coordinator had decided to support her by providing different types of seeds such as tomato, bitter melon, brinjal and cucumber and papaya. And with the support of Jharkhand Vikas Parishad & KFB she developed a nursery of vegetable. She cultivated enough vegetables and started selling vegetables to Block market and earned Rs. 9000 (Nine thousand).

She has realized that attending regular meeting, training, counseling session have brought her to such stage. Now she is very happy and wanted to develop more nursery and a small orchard of vegetables. She is proactive in taking action. She wants to send her children to English medium school for better education.

She thanked to us and expressed her that whatever she improved is the result of KFB and JVP for their support and guidance in her life.
